# Ally Award Evaluation Criteria

To be eligible, nominee must meet the following criteria:

- Must be a member of SCEDA in good standing and may not be nominated by an employee or employer.
- Cannot be classified by SCEDA as a member of a chamber of commerce, government agency (city, county, state, or federal), or economic development agency (city, county, regional). All other classifications are eligible.
- Must have five (5) years of experience working in an economic development related field (please submit current resume/employment history).

Please provide a brief narrative describing why the nominee is eligible for the award, including the following achievements:

These should include the following:

1. Accomplishment of job responsibilities (innovative programs or activities initiated and/or implemented, obstacles overcome, etc.) (30%)
2. Impact of efforts on the community (may include location of industries, job created, capital investment). (30%)
3. Involvement with SCEDA (offices held, activities participated in). (15%)
4. Professional development (educational achievements related to economic development). (10%)
5. Personal traits/characteristics (leadership qualities, enthusiasm, motivation, community involvement). (10%)
6. Any additional comments to support the nomination. (5%)

Please provide no more than three (3) additional letters of recommendation.
