# Local Developer Award Evaluation Criteria

To be eligible, nominee must meet the following criteria:

- Must be a member of SCEDA in good standing and may not be nominated by an employee or employer.
- Must have five (5) years of economic development experience, of which three (3) years must be at a local or regional development organization in a leadership role (please submit current resume/employment history).

In a brief narrative, please comment on the achievements of the nominee you consider worthy of recognition.

These should include the following:

1. Accomplishment of job responsibilities (Innovative programs or activities initiated and/or implemented, obstacles overcome, etc.) (25%)
2. Any unique exemplary efforts related to economic development. (20%)
3. Impact of efforts on the community (may include location of industries, job created, capital investment). (20%)
4. Involvement with SCEDA (offices held, activities participated in). (15%)
5. Professional development (educational achievements related to economic development). (10%)
6. Personal traits/characteristics (leadership qualities, enthusiasm, motivation, community involvement). (5%)
7. Any additional comments to support your nomination. (5%)

Please provide no more than three (3) additional letters of recommendation.
